- For the purpose of postal communication applicants are requested to fill his complete postal address in the application form. Board will not be responsible for postal communication in case of address is wrong.
- 8. Applicants are requested to select the subjects carefully as the selected subject will appear on Admit Card.
- 9. Fee should be paid by Demand Draft or cash (with SEBH cash receipt no.)
- 10. Demand Draft should be drawn in the favour of Secondary Education of Bhiwani(Haryana),
- 11. Attach all necessary Original and self attested true copies of the certificates with the application form.
- 12. Affix a recent passport size photograph in the appropriate box provided in the application form.
- 13. Candidates are requested to verify all the necessary documents as per board's requirement and do not accept the forms with incomplete documents in any case
- 14. Admission form filling is not a final status of admission confirm. All the application form submitted at board will be checked and verified by the board admission section.
- 15. After verification of documents submitted by the applicants, board will issue a Permanent Registration Number (PRN) to the eligible students only. The PRN will be communicated to applicants through SMS and email address provided by the applicants in the application form.
